CUSTOMS POWER OF ATTORNEY to issue the Export Declarations

- as a Direct Representative according to article 18 of the Union Customs Code (UCC) -

We hereby instruct and authorise until revoked in writing, the company:
Zollagentur Berlin Inh. David Lambrecht
Hellersdorfer Weg 35, 12689 Berlin

to issue on our behalf and for our account the export declarations for our outgoing export shipments and to lodge them legally binding as well as to do all actions related to the customs clearance.

The signatory confirms:

- We are the exporter / seller of the goods to be declared; type of export is, unless otherwise indicated, permanent.
- The goods are, unless otherwise indicated, products originating in the EU.
- We will provide the customs tariff number in good time. If the tariff number is not available at the time of lodging the export declaration, the representative is entitled to the independent determination based on the present information. The representative assumes no liability for an incorrect determined tariff number, unless he has not acted grossly negligently or intentionally. In case that we have a Binding Tariff Information we will provide this information to our representative without being asked.
- The goods are not dual-use items according to EU Dual-Use Regulation (Council Regulation (EC) No 428/2009) and do not require export authorisation; otherwise we will in time provide our representative with the required licences.
- Obligations regarding the foreign trade law are under our responsibility. Existing embargo regulations, bans and restrictions as well as any other export restrictions have been complied with.
- We assume sole responsibility for the completeness, accuracy and authenticity of all documents and information which are necessary for the execution of the orders. The representative has neither to verify nor to supplement this.
- The representative has the right to grant sub-authorisation for direct representation.
- We commit ourselves to bear any fees, charges and other costs incurred.
- We agree expressly to the use and storage of our data for the purpose of fulfilling the agreed contractual activities, especially according to the EU General Data Protection Regulation (GDPR). Our agreement we can revoke at any time in writing.
